

CITRUS SCENTED HEAVY DUTY CLEANER / DEGREASER

DESCRIPTION:

USES:

ROCK-SOLV can tackle the most difficult industrial cleaning jobs. It is an effective product for cleaning a variety of surfaces such as concrete floors (sealed and unsealed), ceramics, metal, acrylics, parts and equipment.

PRODUCT USE / APPLICATION:

ROCK-SOLV can be safely applied using mechanical floor scrubbers, brooms or deck brushes, used in 'dip' tanks or spread with mops or rags.

Surfaces that are heavily soiled should be coated with **ROCK-SOLV** and allowed to soak for several minutes before agitating and rinsing. Stubborn oils / grease may require multiple applications of **ROCK-SOLV** to completely remove.

CLEAN UP:

Be sure that all application tools and equipment (including cleaning buckets, mops, scrubbers, etc.) are thoroughly rinsed and cleaned using fresh / potable water.

DISPOSAL:

STORAGE:
